

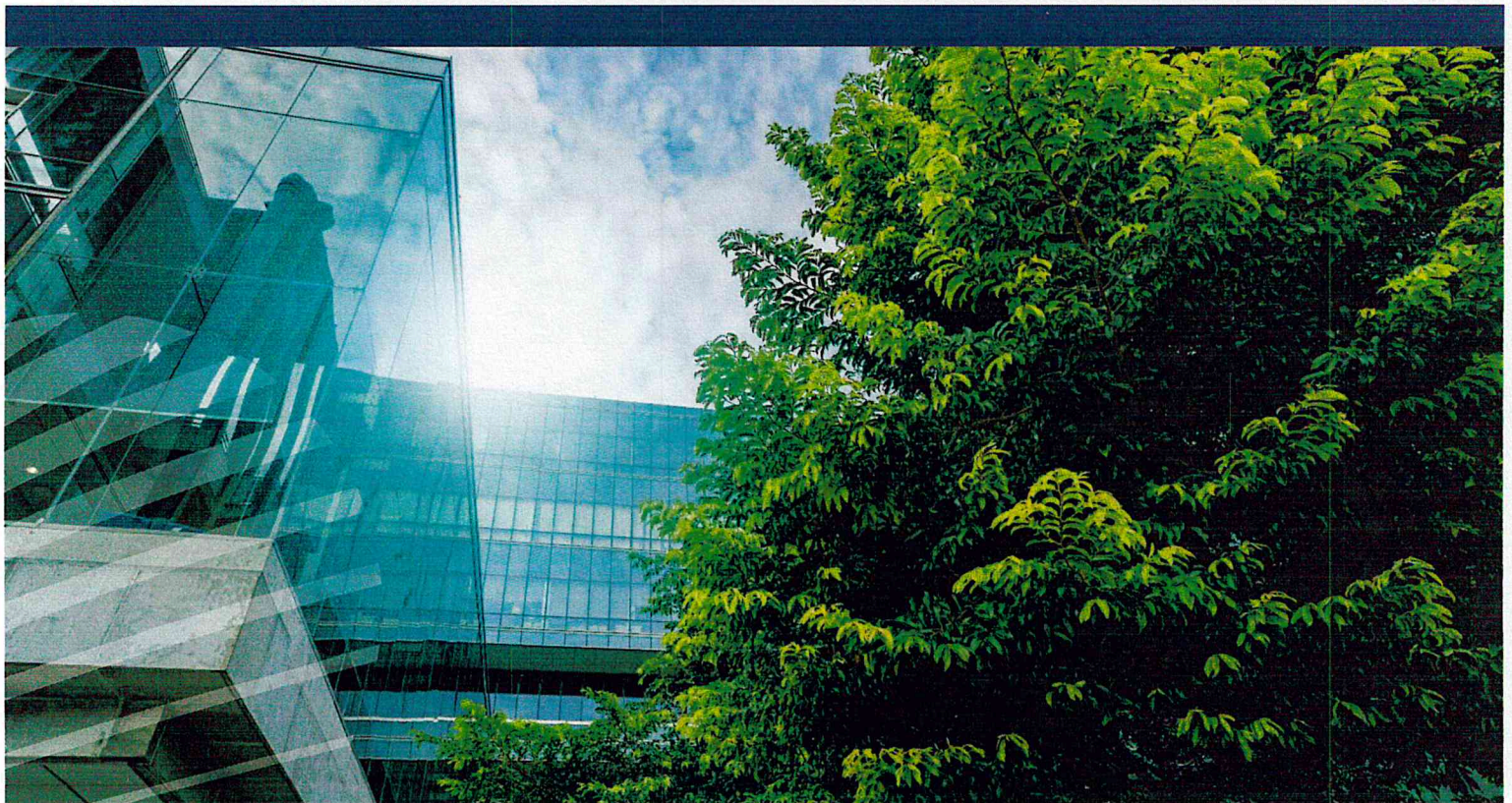

PNO Linking service description

The current service offer is targeted linking the CLIENT as a partner to PACE- Physical Activity, Cycling, and Emissions reduction for sustainable and healthier cities proposal that PNO is preparing for the topic HORIZON-MISS-2025-06-CIT-CANCER-01 that has a deadline for submission to the European Commission on the 4th September 2025. This service includes the following:

- Support to the CLIENT in entering in the project consortium by identifying the added value that the CLIENT could provide to the project, and thereby creating interest in consortium partners in CLIENT skills and competences.
- Support the CLIENT in the proposal preparation phase relatively to the administrative and financial information requested to the CLIENT by the project coordinator:
 - Compile the information that is required for grant proposal through the assessment of project documentation and other background information provided by the CLIENT;
 - Comply with relevant deadlines for the proposal and requests for information;
 - Develop, prepare and submit the complete grant proposal in a timely fashion.
 - Provide support to the CLIENT when corresponding with funding authorities until such time as the relevant grant proposal is fully processed;
 - When needed, assess chances for successful appeal and/or complaint procedures. When decided on in mutual consent, prepare appeals and/or provide support for complaints.

PNO will be in charge of coordinating the entire proposal preparation phase.

Remuneration

The remuneration for this service is composed of a Success Fee.

- Success Fee: The Success fee is due by the CLIENT to PNO only in the case whereby the CLIENT (or the project coordinator) receives the official invite for negotiation by the

European Commission. The success Fee is calculated on the CLIENT's funding established for the project, and is equal to **1.500 €** (one thousand and 5 hundred euros) and a **5%** (five percent) (VAT excluded). The Success Fee will be invoiced at the moment of receiving the first issuing of the grant and in any case (even if such issuing is not received yet) no later than 120 days after receiving the invite for negotiation by the European Commission.

Reimbursement

PNO may invoice the CLIENT and the CLIENT shall pay all amounts invoiced by PNO in accordance with the mentioned in the Remuneration Terms. PNO may transmit to the Client an electronic invoice by electronic mail to the designated email address: faktury@bratislava.sk, or to another email address subsequently notified to PNO in writing at least five (5) working days prior to the entry into effect of such change, in the form of a PDF document (file extension .pdf). The Client declares that it has access to the designated email address and acknowledges that the information made available to it in the electronic invoice delivered to the designated email address constitutes confidential information, which each contracting party is required to keep confidential, except where disclosure to a third party is required under applicable legislation. The electronic invoice shall be deemed to have been delivered at the latest on the first working day following the day on which it was demonstrably dispatched by PNO to the Client by electronic mail to the designated email address.

All invoices shall be payable within 30 days of receipt of a correct invoice. Payments shall be made via direct bank transfer to the following bank account of PNO: ES92 2100 0747 2702 0063 0453.

It is agreed between CLIENT and PNO that any payment made by the CLIENT in the afore-stated bank account shall be deemed to be in full and final payment of the relevant invoices under this Service Agreement.

The Agreement shall become valid on the date of its execution by the duly authorized representatives of the contracting parties and shall become effective on the day following its publication in the Central Register of Contracts pursuant to Section 47a (1) of Act No. 40/1964 Coll., the Civil Code, as amended, in conjunction with Section 5a of Act No. 211/2000 Coll. on Free Access to Information and on Amendments and Supplements to Certain Acts (Freedom of Information Act), as amended.
